2. The last date for submission of Application is 15.03.2012 up-to 1:00 PM Note –

- a. In case of Non Availability of Reserve Candidates, General Category Candidates will be considered on adhoc basic.
- b. Candidate applying for OBC category, certificate in the case of must be issued by the competent authority of GNCT of Delhi.
- c. The reservation in respect of Physically Handicapped is applicable as per rules.
