ELIGIBILITY

For JR: MBBS from recognized university, internship completion certificate, registered with Delhi Medical Council. The candidate having completed compulsory rotary to internship before 31.10.2009 need not apply and if applied will not be considered.

For SR: MBBS with P.G. Degree/Diploma in the concerned specialty from a Recognized University/Institution and should be Registered with Delhi Medical Council.

Note: In case of non-availability of SR with Spl. Degree, diploma candidate with three years experience in the respective Deptt. may be considered in public interest.

***In case of non-availability of SR and JR as age mention above, the age limit is relaxed upto 40 Years for both.**

EMOLUMENTS

For JR, Rs. 15,600/- with Grade Pay Rs. 5400/- plus usual allowance as admissible under the rules.

For SR, Rs. 15,600/- with Grade Pay Rs. 6600/- plus usual allowance as admissible under the rules.

AGE LIMIT: For SR, Below 35 years, and For JR, Below 30 years as on 30, November, 2011. Relaxable for SC/ST by 05 years and for OBC by 03 years (OBC candidates are required to submit their caste certificate issued by the Competent Authority of Govt. of NCT of Delhi).
