TERMS AND CONDITIONS

1. The Quotation complete in all respect duly signed by the tenderer in a sealed envelope super scribed as "Quotation for AMC of Rodent Control / Pest Control in the Aruna Asaf Ali Hospital including mortuary and poor House should be addressed to the Medical Superintendent, AAAGH and be deposited in the tender Box placed in the purchase section up to 19.12.12 by 1:00 P.M. The quotation will be opened on 19.12.12. at 2:00P.M. in the presence of the representative of the firm who may like to be present at the time of opening of the quotation. In case the last date for depositing the quotations is declared as a closed public holiday, the last date will be deemed to be next working day.

Terms and condition, if any from your side should be clearly mentioned.

The rates quoted by the firm should be for the service conforming to the full specification given by the hospital. The percentage of tax if any should invariably be mentioned separately. If no sales / Service tax is chargeable rates should be quoted as net.

The quotation (Price bid) along with technical bid and EMD are to be put in separate envelopes, duly superscribed and both these envelopes are to be placed in third envelope.

- 1. The participant firms will have to deposit a sum of Rs. 5000/- Rupees Five Thousand only) towards earnest money deposit. The earnest money deposit should be furnished in the form of a FDR in favour of Medical Superintendent, AAAGH from a Nationalized Bank payable in Delhi and valid upto 15 months. EMD in any other form will not be accepted and quotations are liable to be rejected at the discretion of the Medical Superintendent.
- 2. The firm should convey its acceptance to the work order and furnish the Security. Deposit @10% of the total value in the form of fixed Deposit Receipt and the scheduled Bank in Favour of the Medical Superintendent, AAAGH Delhi within 10 days from the date of issue of the work order. Security deposit in any other form will not be accepted. The validity period of the security deposit should be for a period of 15 months or the period for AMC whichever is later.
- 3. The Firm on allotment of the contract shall sign the contract on the acceptance of rates quoted by it and on the terms and conditions agreed upon by it within 10 days from the date of intimation letter sent to it failing which the EMD/ Security money will be forfeited in part or full at the discretion of the Medical Superintendent, AAAGH.
- 4. The service under AMC should commence form the date the contract comes into force. In case the firm express its inability to render the service from the stipulated date and requests for extension in the date for commencement of service, the Medical Superintendent has right to impose penalty i.e. 2% of amount of AMC for the first extension for a month or part thereof, secondly

3% of the amount of the AMC for the second extension of another one month and part thereof.

- 5. In the event of non-commencement of the service in the stipulated date and period of the AMC or non-satisfactory service during the period of AMC the medical Superintendent will have right to impose penalty as deemed fit after taking service of the alternative firm at the firm cost and risk or may cancel the entire process and go for fresh LTE by calling quotation and may forfeit in full or part thereof at his discretion. His decision in this regard shall be final and binding.
- 6. The firm will provide the service by the qualified professional teams.
- The firm will arrange weekly visits (preventive measure) each month and on emergency calls without any extra payment. Default in providing service will be penalized @ Rs. 500/- per non-visit.
- 8. Chemical / Physical control measure should be adopted for Rodents pest and crawling insect for the whole hospital
- 9. The Firm should furnish a list of organizations where the firm is engaged on AMC basis during the last year.
- 10. Quotation received after last date will neither be entertained nor returned.
- 11. The rates quoted should be valid for a period of 12 months from the date of opening of the quotations, which may be extended for one year at the discretion of the hospital, if necessary. Also the firm will refund the difference in the event of their entering into AMC at a lesser rate in other organization during the currency of such contract.
